Active Membership in OSOA is open to any Oregon Fire service safety officer. Members of the Section are eligible to vote on all Section ballots; each represented Fire Department or Fire District shall hold only one (1) vote, and are eligible to hold office in the Section.

**ASSOCIATE MEMBERSHIP ..... Charter Membership Dues: \$25.00**

OSOA Associate members shall be persons, Agencies or businesses interested in the goals and objectives of the OSOA who are not eligible for regular membership. They are not eligible to hold elective office and have no voting privileges.

\*Charter membership shall be for April 2009 until July 2010. After that date the dues will remain \$25.00 as long as the OSOA member's agency or business is a member of the OFCA. If the OSOA member's agency or business is not a member of the OFCA the member dues will be \$45.00 beginning July 2010.
