Office of State Fire Marshal: State Fire Marshal Randy Simpson submitted an email report.

DPSST: Deputy Director Eriks Gabliks reported on the budget wrap up. He reviewed the legislative bills that were approved by the governor. He distributed announcements of the Fallen Fire Fighter Memorial scheduled for Sept. 17th. Eriks reported on the Incident Management Team task force meeting and the upcoming fire policy committee meeting. He updated the Board on the available training programs. Eriks advised on the opportunities with Safer grants concerning equipment and personnel.

Western Fire Chiefs' Association: Paul LeSage advised on the progress of ISO rating criteria and on the "Leave Early/Stay and Defend" plan. He reported on the national attention the volunteer comp issue is gaining.
